

# St. Petersburg Primary School ENROLLMENT INFORMATION Kindergarten 2024-2025

**PAYMENT OPTIONS:** We accept credit card, debit card or ACH payments. All payments are made through FACTS.

## NEW STUDENT APPLICATION FEE: (\$100) Required upon application and is non-refundable.

## **ENROLLMENT/RE-ENROLLMENT FEE:** Required upon enrollment/re-enrollment and is non-refundable.

A. Enrollment/Re-Enrollment Fee (\$300) – Non-refundable This annual Enrollment/Re-Enrollment Fee is applied toward processing your child's application, supporting paperwork and FACTS processing fees. This fee is non-refundable. Max \$600 per family.

# ADDITIONAL REQUIRED PAYMENTS:

## A. First Month's Tuition Payment- DUE January 1, 2024 - NON-REFUNDABLE

The January tuition payment is the final step in securing your child's enrollment. If the tuition payment is not received by January 1, 2024, your child will be moved to the end of the waiting list. If you enroll after January 1, 2024, the first month's tuition is due at the time of your enrollment. **This payment is non-refundable and is the first of ten monthly payments (January 2024, August-December 2024, February – May 2025).** 

### B. Curriculum Fee (\$300) – Due June 1, 2024

The Curriculum Fee helps offset costs associated with curriculum upgrades, consumable supplies, technology upgrades, and enrichment programming.

## TUITION DISCOUNTS AND SCHOLARSHIPS: (One discount OR scholarship per family)

- <u>Sibling Discount</u> If you have more than one child that attends SPPS, you are eligible for a sibling discount. The oldest child's tuition is at the full tuition price. Then each subsequent child/sibling will receive a 5% discount on their tuition. This does not include Aftercare.
- <u>First Presbyterian Church Discount</u> If you are a member of First Presbyterian Church, you are eligible for a 5% discount on each child's tuition.
- <u>State Scholarship Programs</u> SPP accepts the Family Empowerment Scholarship for Students with Unique Abilities, Florida Tax Credit Scholarship, Family Empowerment Scholarship for Educational Options and Hope Scholarship through the state of Florida. - <u>St. Petersburg Primary School's Scholarship Program</u> Our goal is to provide a faith-based early childhood education to children whose families cannot afford the full tuition to attend SPPS.
